BACKGROUND: The 2020 Annual Drainage project consists of a group of projects to mitigate drainage issues and repair culverts on Bainbridge Island. This year, the plan includes the replacement of drainage pipes at Wyatt Way and South Beach. The project also included landscape mitigation work at Waterfront Park and water-quality improvements to the Windsong Loop stormwater pond.

The 2020 Annual Drainage project consists of a group of projects to mitigate drainage issues and repair culverts on Bainbridge Island. This year, the plan includes the replacement of drainage pipes at Wyatt Way and South Beach. The project also included landscape mitigation work at Waterfront Park and water-quality improvements to the Windsong Loop stormwater pond.

Bids were solicited by local advertising, Daily Journal of Commerce and the bid listserv. The bid opening was held on Friday, August 21, 2020 and one bid was received. The one bid received was from Pape & Sons Inc. in the base bid amount of \$267,090, a 35% increase over the engineer's estimate of \$188,052.50. The Department will be evaluating alternative options for delivering the most critical of these projects in the

short-term through use of the City's small works roster, and also evaluating some longer term solutions for delivering drainage repair and replacement projects.

Pursuant to the project specifications and advertisement, the City of Bainbridge Island reserves the right to reject any and all bids and to waive informalities in the bidding process.

City Staff recommends rejecting the one bid received from Pape & Sons Inc. at the 2020 Annual Drainage project bid opening and re-advertise the project at a later date.
