PROJECT DESCRIPTION:

Staff is requesting Council approval of this CCPA with Grainger, Inc., to facilitate the purchase of general maintenance, repair and operation (MRO) supplies, parts, and materials needed to perform and complete operations and maintenance of the city's water and wastewater facilities, assets and infrastructure. The not to exceed (NTE) amount of this contract has been set to \$300,000.
