SUGGESTED ACTION:

Applicant is requesting to rezone 88.1+/- acres from AG (General Agriculture), R-20 (Single-Family Residential), and R-40 (Single-Family Residential) to R-20 for a conservation design community. The applicant is also seeking a concurrent variance to Article 23, Section 23.5, A to allow for house lots to encroach upon Primary Conservation Areas; to Article 23, Section 23.5, D, to allow lots to not abut an undisturbed area of greenspace of 50 ft. in depth; to Article 23, Section 23.5, F to allow for more than 10 lots to be contiguous to each other, to reduce the minimum greenspace access strip width from 50' to 0', and to allow the width of the greenspace access strip to not extend the full depth of the adjacent lots; and to Article 23, Section 23.10-1, to reduce the exterior buffer adjacent to property zoned AG from 75 ft. to 50 ft. for lots 71-83 and the amenity area. The applicant is also requesting approval for private streets.
