**EXPLANATION:** 

The Tree and Land Preservation Board has provided recommendations for updating the City of Bradenton Land Development Code. Specifically, the code sections that regulate the composition of the Tree and Land Preservation Board (Chapter 2) and the planting of trees in City rights-of-way (Chapter 4).

Planning Commission heard the case at the August 21, 2024, meeting. The Planning Commission voted to recommend approval of the proposed changes. Additionally, the Planning Commission voted to instruct the City Attorney to craft an additional amendment to 2.1.3.3.b, removing the power of the Tree and Land Preservation Board to delay the removal of a tree for up to 180 days.

The first reading at City Council was held on November 6, 2024.
