It is in the best interest of the environment and the residents of the City of Bradenton that private laterals and private wastewater collection and transmissions systems ("WCTS") are maintained in a state of good working order.

The City finds it is in the best interest of City residents to amend the Code of Ordinances to require owners of private laterals and private WCTS connected to the City's sewer collection system to maintain such private laterals and private WCTS in good working order, to require inspections of such private laterals and private WCTS upon certain occurrences, to provide requirements for such inspections, to require the replacement or rehabilitation of defective private laterals and private WCTS, and to provide for any violations to be subject to enforcement.
