SUBJECT: **Resolution 25-24, Case PLN-SUP-24-0007:**
Request for a Special Use Permit to allow for a sidewalk café with alcoholic beverage sales; to be located at 316 12th Street West (Parcel ID 3295600005) in the T5 (Urban Center) transect zoning district. Application filed by Joshua Hatch (agent) for Landmark 1896, LLC (owner).

SUGGESTED ACTION: Motion to recommend to City Council either approval or denial of Resolution 25-24, Case PLN-SUP-24-0007.

If the Commission wishes to recommend approval, staff recommends that the following stipulations be applied to the approval:

- a. The approved Resolution, including the approved site plan and conditions shall be on display and accessible on the Property during business hours.
- b. Within 30 days following the approval, the Property Owner shall execute an Indemnification Agreement in a form acceptable to the City.
- c. No more than 2-tables may remain on the sidewalk when the business is closed. The items shall be placed adjacent to the building unit.
- d. Clear pedestrian access on the public sidewalk of no less than 5' shall be maintained at all times in a way that neither seating or tables affect the ingress/egress of travel, the safety or pedestrian and traffic circulation.
- e. The property/business owner shall obtain all State licenses permitting the sale of alcohol as part of

- the sidewalk café.
- f. Any cleaning solution used to clean the sidewalk café area shall be approved by the Bradenton Public Works.
 - g. Any future increase in seating for the sidewalk café area shall be approved by City Council.

EXPLANATION:

The applicant has submitted a Special Use application requesting permission to allow a sidewalk café with alcoholic beverage sales at 316 12th Street West.

Jaxx Wing Company is a new business in downtown Bradenton and the proposed request will ensure compliance to the City of Bradenton's Form Based Code and Land Use Regulations, should approval be granted by City Council.

According to the submitted application materials, the proposed café area will be located on the sidewalk along 12th Street West. Following is a summary of the request:

- Area size: 15' x 19' (sidewalk depth and unit width).
- Number of Tables: 4-tables.
- Number of Seats: 8-chairs.
- Bussing and Hostess Stations: No.
- Table Umbrellas: No.
- Requesting permission to allow for the 2-tables to remain on the sidewalk and those tables are identified on the plan as tables 1 and 2.
