SUBJECT: Purchase of the FY27 Fleet Vehicles Through a Statewide Cooperative Contract

INTRODUCTION:

The purpose of this agenda item is to approve the purchase of replacement fleet vehicles and one additional fleet vehicle, as budgeted in FY27, through a Statewide Cooperative Contract.

BACKGROUND:

The Town of Collierville maintains a fleet of pickup trucks, vans, and utility vehicles that support operations across multiple departments, including Public Services, Public Utilities, Development, Information Technology, Animal Control, and Parks and Recreation. These vehicles are used daily to transport personnel, tools, equipment, and materials, perform routine maintenance, respond to service requests, and support emergency operations throughout the Town.

DISCUSSION:

In FY26, Fleet Services developed a comprehensive vehicle replacement plan based on vehicle age, service history, maintenance costs, reliability, and overall condition. The vehicles presented for replacement as part of this request have been evaluated using this replacement tool and meet the established replacement criteria.

This FY27 purchase includes fleet vehicle purchases for the following departments and divisions:

Public Services

Grounds & Parks Maintenance

- Replace Unit #604 (2008 Chevrolet 3500 van) with a new 2027 Ford Transit 350 van.
- Replace Unit #641 (2002 Chevrolet 2500 pickup) with a new 2027 Ford 2500 pickup

Facilities Maintenance

- Replace Unit #116 (2002 Chevrolet 1500 pickup) with a new 2027 Ford 2500 pickup with utility bed.

Streets and Drainage

- Replace Unit #278 (2012 Dodge 1500 pickup) with new 2026 Ford F-150 pickup.
- Replace Unit #262 (2003 Chevrolet 1500 pickup) with a new 2026 Ford F-150 pickup.
- Purchase New 2026 Ford F-150 pickup for Right of Way Crew.

Sanitation

- Replace Unit #440 (2012 Dodge 1500 pickup) with a new 2026 Ford F-150 pickup.

Development

Engineering

- Replace Unit #809 (2000 Ford F-150 pickup) with new 2026 Ford F-150 pickup.

Parks and Recreation

- Replace Unit #641 (2002 Chevrolet 1500 pickup) with new 2026 Ford F-150 pickup.

Public Utilities

Water Distribution

- Replace Unit #346 (2014 Ford F-150 pickup) with new 2026 Ford F-150 pickup.

Wastewater Collection

- Replace Unit #338 (2012 Ford F-250 pickup) with new 2027 Ford F-250 pickup with utility bed.

Wastewater Treatment Plant

- Replace Unit #339 (2012 Ford F-250 pickup) with new 2027 Ford F-250 pickup with utility bed.
