SUBJECT: Review of Bids and Award of Contract for the FY 2026 Street Resurfacing Program

INTRODUCTION:

The purpose of this agenda item is to award the annual contract for the Town of Collierville's Street Resurfacing Program for FY 2026.

BACKGROUND:

This project involves patching, leveling and asphalt overlay of various Town street. \$1,962,259 was budgeted in the Streets and Drainage Fund and \$1,037,741 is in the State Street Aid Fund for the annual resurfacing project. The total amount budgeted for FY 2026 is \$3,000,000.

DISCUSSION:

Following the approval of the proposed street list, Public Works personnel submitted a requisition to the Procurement Department for the street resurfacing project. The Procurement Department prepared a bid and notified (18) vendors. On September 17, 2025, the Procurement Department opened (4) bids for the annual resurfacing project. Standard Construction Company Inc. submitted the lowest bid for the project with a total of \$2,958,313. The alternate bid (additional add-on streets) of \$428,058 will only be considered for construction if available funds remain at the end of the project.
