**SUBJECT:** Resolution 2025-25 - A Resolution to Amend the FY 2025 General Fund and

Non-Capital Projects Budgets

#### **INTRODUCTION:**

The purpose of this agenda item is: A. to amend the FY 2025 General Fund Budget to appropriate General Fund assigned fund balance and budget the related capital expenditure; and, B. to amend the FY 2025 Non-Capital Projects revenue line-item and budget the related capital expenditure.

### **DISCUSSION:**

## A. General Fund Budget Amendment

The Queen Oaks Basin Study project was adopted as part of the Town's FY 2025 Non-Capital Projects budget with \$175,000.00 of Stormwater funds appropriated. The final cost for the proposal is \$192,359.00.

Engineering is requesting a budget amendment to appropriate \$20,000.00 of Stormwater assigned fund balance for the Queen Oaks Basin Study project to cover the cost of the study proposal. This will bring the total project budget to \$195,000.00. (Please refer to Exhibit A and the Memo "Budget Amendment; Queen Oaks Basin Study.")

# B. Non-Capital Projects Budget Amendment

If the Queen Oaks Basin Study budget amendment is approved, the Finance Department is requesting a budget amendment to appropriate and reflect the \$20,000.00 in the Town's Non-Capital Projects. (Please refer to Exhibit B)
