SUBJECT: Review of Bids and Award of Contract for Chemical Weed Control Services

INTRODUCTION:

The purpose of this agenda item is to approve a contract for chemical weed control services at various Town-owned locations.

BACKGROUND:

The Town has utilized contracted chemical weed control services since 2009 to provide pre- and post-emergent weed control at Town facilities, parks, athletic fields, roadway medians, and right-of-way locations. These services help maintain the appearance, safety, and long-term condition of Town assets.

DISCUSSION:

With the current contract for chemical weed control set to expire on January 26, 2026, Public Works staff submitted a requisition to bid a new contract. The Procurement Division prepared the bid and notified eighteen (18) vendors of the bid availability. Seven (7) vendors requested a copy of the bid specifications, and two (2) bids were received. Below is a list of the lump sum bids received.

Bids were received and evaluated for accuracy and compliance with the bid specifications. During the review process, staff identified inconsistencies in the add alternate pricing submitted by the bidders, which rendered the add alternates unreliable and resulted in their removal from consideration.

Additionally, while Herbi-Systems, Inc. submitted a base bid lump sum of \$139,918.05 (Base Bid), staff's verification of unit prices and quantities determined the correct calculated total to be \$140,668.05. Town staff contacted Herbi-systems, Inc. regarding this discrepancy, and the vendor acknowledged the calculation error and agreed to honor the original submitted bid price of \$139,918.05. Based on this review, staff recommends proceeding with and awarding the contract using the base bid amount only.

A copy of the bid evaluation, bid specifications, and proposed contract are attached to this report for reference.
