BACKGROUND/SUMMARY:

On August 27, 2024, the Board of Supervisors adopted Ordinance 1067, which enacted restrictions banning the use of certain public rights-of-way as sleeping or living accommodations. The ordinance went into effect September 26, 2024. Information regarding an encampment cleanup policy and potential next steps for the San Benito River cleanup was presented to the Board of Supervisors on October 15, 2024. The Board approved the

policy with clarification that Admin would be the lead agency, granted a full time Sheriff Deputy Position to monitor the San Benito River, and instructed staff to return at the November 12, 2024 regular meeting for discussion of the cost estimates, timeline, and updates. On November 12, 2024, the Board of Supervisors adopted by resolution the encampment cleanup policy which sets forth guidelines for the clean-up of encampments on public right of ways and public property.

Prior to cleanup of the San Benito River on private property, trespass authorization for County staff and contractor access is required for encampment enforcement and abatement efforts. For Board approval, a

trespass/letter of authority was developed to grant consent to the Sheriff's Office and County staff (including contractors) to enter private property for ongoing abatement and enforcement. Additionally, a cover letter was developed to summarize the Board's actions related to the San Benito River cleanup efforts and projected next steps. The cover letter and trespass/letter of authority, along with a flyer from the Elections Department regarding notary services available at their office will be mailed to each property owner (approximately 40 mailers covering 75 addresses) and will ultimately be the County's first formal means of communication this year related to this work.
