BACKGROUND/SUMMARY:

The State of California mandates that the California Building Standards Code (Title 24, California Code of Regulations) be updated and adopted every three years—a process commonly known as the Tri-Annual Code Update. Pursuant to the California Health and Safety Code, the California Building Standards Commission adopted and published the 2025 California Building Standards Code on July 1, 2025, with an effective date of January 1, 2026, for all cities and counties statewide. The 2025 California Building Standards Code (Title 24) consists of the following 12 parts:

1. Administrative Code
2. Building Code (CBC)
3. Residential Code

4. Electrical Code
5. Mechanical Code
6. Plumbing Code
7. Energy Code
8. Fire Code
9. Green Building Standards Code (CALGreen)
10. Existing Building Code (CEBC)
11. Historical Building Code
12. Referenced Standards Code

The County adopts the California Building Standards Code by amending the County's Code (Chapter 21). Staff is recommending that the County Board of Supervisors (BOS) approve the Ordinance to amend Chapter 21 of Articles I and II of the San Benito County Code of Ordinances to adopt the 2025 California Building Codes. In addition to adopting the 2025 California Building Standards Code, staff is recommending that the BOS adopt the 2024 International Property Maintenance Code to replace the currently adopted 2021 version & adopt the 2024 Uniform Swimming Pool Spa Hot Tub Code as published by the International Association of Plumbing and Mechanical Officials (IAPMO) as a stand-alone document to replace the currently adopted 2021 version. These codes are not part of the mandatory 2025 California Building Standards Code but are beneficial in addressing code enforcement issues related to property management & pool construction.
