#### **BACKGROUND/SUMMARY:**

The State of California launched the Homeless Housing Assistance and Prevention (HHAP) Program in February 2020. San Benito County Community Services & Workforce Development (CSWD) applied for these funds through the local Continuum of Care (CoC) and received approval. On September 8, 2020, an agreement was executed to allocate \$283,478.00 to support a Rental Assistance and Rapid Rehousing services for San Benito County residents experiencing homelessness or at risk of becoming homeless.

The initial grant term covered the period from September 1, 2020, through June 30, 2025. CSWD has

fully expended 100% of the initial grant funding by supporting the COVID Continuity activities in the amount of \$42,522 for emergency shelter to include Project Room Key providing hotel vouchers. The remaining funds in the amount of \$240,956 were allocated to provide Rapid Rehousing services—including rental assistance—personnel and offering administrative support. During the program date term, a total of 5 households and 10 individuals received rental assistance for up to 12 months and a total of 60 individuals received COVID-19 continuity support in the form of hotel vouchers.

On March 18, 2025, the local Continuum of Care (CoC) approved an additional \$10,582.00 for San Benito County CSWD to expand its Rental Assistance and Rapid Rehousing services. These funds, reallocated from unspent resources returned by other organizations, will be used to provide rental assistance to new or existing clients until fully expended—anticipated within 1 to 2 months, but no later than June 30, 2025.

This additional funding will help existing clients remain housed, with rental assistance provided in accordance with program guidelines. Each participating household will contribute 30% of their monthly income toward rent, with the remaining portion covered by the program, ensuring a shared responsibility approach to housing stability.

The attached amendment has been signed by both parties due to the short turnaround time, as the contract amendment is set to expire on June 30, 2025. Additionally, there was some confusion stemming from a similar contract with the State Business, Consumer Services, for the Housing Agency, Homeless Housing Assistance and Prevention Program Round 1 (HHAP-R1), which granted the HHSA Director delegation authority to sign amendments and other documents related to that grant. For your review and approval, the HHAP-R1 contract is also enclosed.
