The Probation Department's existing contract with BI Incorporated/Omnia Partners provides GPS monitoring for probation and court clients. The contract funding is supported by the AB 109 Public Safety Realignment Grant approved by the Community Corrections Partnership on October 10, 2022, (CCP) Executive Board and by the Board of Supervisors on October 25, 2022. The GPS monitoring contract is necessary for probation clients and for fulfilling the MOU between the Superior Court of California San Benito County's SB129 pretrial program clients.
