BACKGROUND/SUMMARY:

The Community Action Board requests the appointment of Ms. Victoria Montoya as the District #2 Representative of the Low-Income. An election was held from 5:15-5:30 P.M. prior on 1/12/23 prior to the regular CAB meeting and the application of Victoria Montoya was democratically selected by members of the public for that supervisorial district. The CAB approved the application of Victoria Montoya at their meeting on 1/12/23 and the CAB requests that the appointment be effective 1/12/2023.

The Community Action Board's tripartite board reflects and promotes the unique anti-poverty leadership, action, and mobilization responsibilities assigned by law to community action agencies. CAB is responsible for assuring that it assesses and responds to the causes and conditions of poverty in their community, achieve anticipated family and community out comes, and remain administratively and fiscally sound.

As a tripartite boards, its membership consists of 1) One-third of tripartite board membership must be democratically elected representatives of low-income individuals and families who reside in neighborhoods being served; 2) One-third must be elected officials, holding office at their time of selection, or their representatives; and 3) The remaining board members must be chosen from "business, industry, labor, religious, law enforcement, education, or other major groups and interests in

the community served.

The CAB has been working closely with staff and has been very supportive of the programs currently being provided including homeless and housing programs. The board has been very engaged with community outreach, with the development of the strategic plan, and with the board's committees.
