BACKGROUND/SUMMARY:

When California became a State, it established the Civil Grand Jury system to ensure local government efficiency, accountability, and responsiveness. Made up of volunteer residents in each County, the Civil Grand Jury is the "citizens' watchdog" appointed by the California Superior County for one year to formally investigate the efficiency and responsiveness of any local government entity. The Grand Jury's findings and recommendations for improvement are then presented to the San Benito County Board of Supervisors and published on the San Benito County website and in local media.

In San Benito County, 19 Grand Jurors are appointed to serve for one (1) year but up to two (2) consecutive years. The Grand Jury is an official body of the Court with independent authority that is not answerable to administrators or legislators. Its principal purpose is to protect the public interest. Appointment to the Grand Jury provides citizens a means to participate in the affairs of local governments.

For Board consideration and approval, a proclamation is presented designating February 2023 as Civil Grant Jury Month in San Benito County in recognition of the time and effort that the Civil Grant Jury(s) continually makes to support the community.
