Approve Amendment No. 1 for Sun Street Centers for Women's Sober Living Environment (SLE) in the amount of \$89,403.00 for a fee-for-service contract total not to exceed \$233,408.00 for expansion of additional beds and services in the SLE program for the term of July 1, 2024 through June 30, 2026, authorize Chair to sign agreement, and approve Budget Adjustment in the amount of \$89,403.00 covered by an existing appropriations under the expected federal Medi-Cal revenue.

BACKGROUND/SUMMARY:

This contract allows for the purchase of Sober Living Environment (SLE) beds for women on a fee for service basis. The Women's SLE is a separate residence services from the Men's SLE and separate from Women's Residential Treatment. This resource allows for a local placement option for women needing this level of supervision when mandated by our local Child Protective Services as well as women mandated to this care level by Probation and the Court system.

This provider differs from residential providers as there is no treatment provided at this location but this sober living environment is instead used to allow women to live in a sober space while attending mandated or voluntary treatment via San Benito County Behavioral Health. SLEs provide 24 hour safe, residential housing in a setting that is free from alcohol and other drugs. Most of the referrals to this provider are through our MOU with probation and CPS to provide a sober living space for individuals receiving mandated treatment. This provider is licensed and is beholden to the California Consortium of Addition Programs and Professionals (CCAPP) SLE Standards.

The need for the additional funding is to compensate for the expansion of bed availability and expansion of services. An additional SLE has been created to allow female clients with children to remain together as the client undergoes their treatment. Currently 12 clients and 3 children have been served with the current FY 24-25 contract. Additional bed availability is needed to meet clients need. As more services are offered more clients are needing to be served.

RFP AND BID HISTORY:

Based on the BOS presentation from January 25, 2022, this contractor’s facility falls under the category of SUDs Treatment Contracts that include Residential facilities. An RFP for this type of contract is not advised because these type of fee for services contracts are secured in the event an individual presents themselves needing this level of care and needs to be placed at this type of facility. SBCBH tries to contract with qualified and licensed facilities of this type in the surrounding area to adhere to time and distance standards. Currently, this is the only known licensed women’s SLE facility in San Benito County.
