BACKGROUND/SUMMARY:

Interim is well-known throughout Monterey County and the central coast for their expertise and resources in facility operation including their Manzanita Program which is their short-term crisis residential treatment program. It is an alternative to inpatient psychiatric care for adult clients. They provide multiple levels of care including a structured & non-institutionalized environment, individual & group counseling, medication support, onsite structured social rehabilitation groups, and discharge planning.

The contract is retroactive to April 1st because SBCBH had a crisis client in April that needed the Interim's services. The contractor needed to request the approval of their board for the contract which took some additional time in between the correspondences.

This a fee for service agreement. Payment is only made if services are utilized during the contract term.
