BACKGROUND/SUMMARY:

Peninsula Pediatric Therapy is being contracted to provide Occupational Therapist (OT) and Physical Therapy (PT) services to the Medical Therapy Unit patients receiving therapeutic services at the California Children's Services Medical Therapy Unit (CCS/MTU) funded through the county's CCS program.

The Medical Therapy Unit provides therapeutic services to approximately forty-six (46) children from San Benito County who have certain disabilities and qualify for the services under the state mandated program. These services include both occupational and physical therapy, currently being administered by two therapists daily and an on-site doctor who oversees the care of the patients. The primary duties of the MTU therapists is to provide direct or indirect occupational and physical therapy services as prescribed by physicians for physically disabled children eligible for CCS program services. Further, the

therapists also plan and participate in the Medical Therapy Unit's medical clinics and consult and work with physicians and other health providers in evaluating children's disabilities and in planning and evaluating treatment programs. Including coordinating and managing medical therapy conference physician services.

Peninsula Pediatric Therapy has provided ongoing therapy to the Medical Therapy Unit for roughly ten years. President and Lead Physical Therapy Elisa Pollard-Gensberg has a long-standing relationship and unremarkable history with the MTU patients, the parents, the school districts as well and with County office of Education- SELPA Director. Through this contract, Peninsula Pediatric Therapy will continue to provide therapists to provide both occupational and physical therapy services for the Medical Therapy Unit patients.

Peninsula Pediatric Therapy will continue to provide medical therapy recommendations for patients with other community services including medical supplies and other treatment due to her considerable amount of expertise in the CCS program, as well as other responsibilities outlined in her contract related to day-to-day MTU work.
