BACKGROUND/SUMMARY:

Section 2121 of the Streets and Highways Code provides that in May of each year, each County shall submit to the Department of Transportation (CALTRANS) any additions to or exclusions from its mileage of maintained County roads, specifying the termini and mileage of each route added or excluded.

The Board of Supervisors adopted Resolution No. 2024-53 on May 7, 2024, certifying the updated County maintained roads with total mileage of 449.287 miles for the year 2024. Since adoption of Resolution No. 2024-53, there has been neither additions to nor exclusions from the mileage of

maintained County roads. CALTRANS requests that the County's Board of Supervisors annually certify, by Resolution, the maintained mileage of County roadways irrespective of change in termini or mileage.
