CFD 2018-01 Residential Services (Sunnyside Estates):

Transfer \$27,500.00 from Services and Supplies Administrative Support to other Services and Supplies accounts, and increase the appropriate expenditures to various Services & Supplies and Other Charges accounts by \$26,745.00 to correct the budgets for various maintenance and services contracts and tasks for FY 24/25.

CFD 2018-01 Residential Services (Promontory/Bluffs):

Transferring existing Appropriations of \$4,000.00 from Charges for Services CFD Charges to Benefit Assessment Charges and increasing the revenue by \$81,016.00 to indicate the correct estimated annual Tax Assessments for FY 24/25. Transfer \$1,000.00 from Services and Supplies Administrative Support to other Services and Supplies and Other Charges accounts, and increase the appropriate expenditures to various Services & Supplies and Other Charges accounts by \$5,025.00 to correct the budgets for various maintenance and services contracts and tasks for FY 24/25.

CFD 2018-01 Residential Services (San Juan Oaks):

Increasing the Appropriate revenue by \$29,990.00 to indicate the correct estimated annual Tax Assessments for FY 24/25.
