BACKGROUND/SUMMARY:

WINCAMS is used to report all road project expenditures. This maintenance contract provides support for technical questions, configuration, annual updates and trouble shooting. The State annually reviews all road transactions recorded in WINCAMS to determine whether the County is in compliance with required financial reporting of road transactions. Funding is provided through State highway use taxes. The maintenance cost is budgeted in the current year. Non-compliance could potentially result in reduced Federal and State funding for the County's road works. This is for a three year maintenance contract.
