Approve reallocations of \$695,342.97 of RSTP funds from the Fairview/Acquistapace/Comstock intersection project to the Striping Improvements - Various Locations project for additional estimated costs needed for that public works project and the reallocation of \$423,648.38 of General Fund/Benefit Fee funds from the 'San Juan Canyon Rd - Salinas Rd to 6.4 miles beyond Salinas Rd' project to the Panoche Road and New Idria Road project for additional estimated costs needed for that public works project. No budget transfers are required as the funding is already in the existing RSTP project budget. SBC FILE NUMBER: 105.3

BACKGROUND/SUMMARY:

During the budget hearings, the Board approved \$700,000 for the project 'Striping Improvements - Various Locations'. Per the requests from multiple community members and a County Supervisor, the scope of that work was expanded to include striping adjacent to Anzar High School and striping along Santa Ana Valley Road. These two segment essentially doubled the original scope of work. As it is more cost effective to perform all striping improvement work within a single project, this request is to transfer \$695,342.97 from the Fairview/Acquistapace/Comstock intersection project to the Striping Improvements - Various Locations project. The intersection project will be reduced to a total budget of \$324,657.03 which will allow for the design and environmental analysis to be completed. However, construction funding will still be needed in a future budget. No budget transfer is required as the funds already

existing in the RSTP fund budget. A summary of the transfer is as follows for these two projects:

- Striping Improvements Various Locations: Total budget increases from \$700,000.00 to a total of \$1,395,342.97
- Fairview/Acquistapace/Comstock intersection: Total budget decreases from \$1,020,000.00 to a total of \$324,657.03

During the budget hearings, the Board approved \$2,600,000 for the project Panoche Road and New Idria Road project . However, due to higher oil costs and a change of scope to install oil/sand along New Idria Road, an additional \$423,648.38 of General Fund/Benefit Fee funds from the San Juan Canyon Rd - Salinas Rd to 6.4 miles beyond Salinas Rd project to the Panoche Road and New Idria Road is needed. The San Juan Canyon Road project is an estimated budget at this time, and that budget will be refined when the design of that project has progressed. No budget transfer is required as the funding is already in the existing General Fund/Benefit Fee projects budget. A summary of the transfer is as follows for these two projects:

- Panoche Road and New Idria Road: Total budget increases from \$2,600,000 to a total of \$3,023,648.63
- San Juan Canyon Rd Salinas Rd to 6.4 miles beyond Salinas Rd: Total budget decreases from \$6,864,000.00 to a total of \$6,440,351.62
