#### **BACKGROUND/SUMMARY:**

On January 17th, 2023, the Board of Supervisors adopted Resolution 2023-03 confirming and ratifying the Proclamation issued by the Director of Emergency Services and continuing the local emergency in San Benito County.

This Proclamation applies to the entire County of San Benito.

San Benito County was added to the major disaster declaration on Jan. 26<sup>th</sup> and was awarded Public Assistance for those areas determined to have been adversely affected by the event declared a major disaster by the President.

The county is moving into a Recovery process and hosted a Local Assistance Center in partnership with CalOES, free debris dump day, working on additional debris removal opportunities, and has distributed 400 emergency kits.
