BACKGROUND/SUMMARY:

The Emergency Medical Services (EMS) Agency is required by the Health & Safety Code 1797.202 to have a licensed physician with substantial experience in the practice of Emergency Medicine, providing medical control, and assures medical accountability of the EMS System.

This agenda item is an amendment #1 to the contract with Dr. Michael Bogey as the EMS Medical Director for San Benito County. His current contract expires December 31, 2025. The renewal will begin January 1, 2026 and expire December 31, 2026, for an amount not to exceed \$60,000.00, plus necessary travel expenses not to exceed \$5,000.00 annually.

Dr. Bogey is the only Chief of Emergency Physician in San Benito County eligible for the role of EMS Medical Director. The original contract was for one year to give Dr. Bogey an opportunity to see if this role worked with his primary role of Chief of Emergency Physician with Hazel Hawkins Hospital.

The previous contract for EMS Medical Director was held for over ten years by Dr. Ghilarducci until his

retirement last year.

Total contract

\$130,000 (\$60,000 salary * 2 years = \$120,000 + (\$5,000 travel * 2 years = \$10,000) = \$130,000.
