#### BACKGROUND/SUMMARY:

The project is the update to the County of San Benito's General Plan Housing Element. State law requires every city and county to adopt a general plan containing at least seven mandatory elements (chapters). One required element is the Housing Element, which must be updated every eight years. The County's updated Housing Element covers the planning period of 2023 to 2031. The purpose for requiring local Housing Elements is to ensure that each jurisdiction provide its fair share of regional demand for housing. The State of California Department of Housing and Community Development (HCD) allocates regional shares of statewide housing needs. These allocations are provided to a region's Council of Governments, which determines each jurisdiction's fair share contribution. The San Benito County Council of Governments (COG) encompasses the cities of Hollister and San Juan

Bautista and the unincorporated areas of San Benito County. COG establishes each jurisdiction's contribution through the state mandated Regional Housing Needs Allocation (RHNA) as provided by HCD. The RHNA for the period of 2023–2031 for the COG region is 2,194 new housing units. The table below shows the unincorporated County of San Benito's fair-share contribution.

State law requires that all Housing Elements address these key topics: housing needs assessment, constraints, resources and opportunities, assessment of fair housing, candidate housing sites, and planning. Analysis of these topics provides the foundation for the preparation of a Housing Element. The San Benito County Housing Element profiles community demographics and examines housing needs of various demographic groups, including owners versus renters, lower-income households, overcrowded households, the elderly, special needs groups, and the homeless, among others. This information is detailed in the updated Housing Element.
