BACKGROUND/SUMMARY:

The California Department of Food and Agriculture (CDFA) wishes to contract with County of San Benito to perform nursery inspections at all producer/wholesale nursery locations within the County on their behalf. The term of this agreement is from July 1, 2022 to June 30, 2023.

Inspections are performed on nursery stock entering San Benito County and nursery stock produced within the county. These inspections help protect the environment and foster fair competition by assuring the customer that plants are free from certain plant pests. This allows growers to ship their products throughout the state, nation and world.

The funding is sufficient to cover our costs. The anticipated revenue has been budgeted in the Agricultural Commissioner's Budget for FY 2022/2023.

Work will be performed by existing staff.
