BACKGROUND/SUMMARY:

The Communications Ad Hoc was established in April 2023 to address issues related to communication infrastructure in San Benito County. Since its formation, staff have provided updates on the status of the county's communication system, explored potential solutions, and proposed improvements. Presentations on the topic of communications were delivered to both the Information Technology and County Facilities Committees in October 2023 and March 2024, respectively. After careful consideration, the recommendation was moving forward with the California Radio Interoperable System (CRIS) Program.

The California Radio Interoperable System (CRIS) Program, launched in 2019, is part of a strategic initiative to enhance California's public safety communications. By utilizing state-of-the-art radio technology, the program aims to provide the state's first responder community with a more reliable and

effective communication tool. Additional information about the CRIS Program is available on the Cal OES (California Governor's Office of Emergency Services) website.

Staff is recommending the following:

- 1. Ratify the attached executed agreement with the State of California office of Emergency Services;
- 2. Delegate Authority to CAO or Designee to amended and execute any necessary amendments or contracts for the CRIS system in an amount not to exceed \$1.25 million
