## BACKGROUND/SUMMARY:

On October 19, 2022, the County received confirmation that the County was awarded a grant of \$9,900,000.00 in building forward grant funds as part of the which requires the County of San Benito to contribute \$4,950,000 toward the project.

The County has to confirm the availability of the equivalent, ensuring the availability of matching funds of \$4,950,000. The County's contribution will come from the following sources.

- ARPA \$2,500,000.00.
- Library Impact Fees \$1,184,403.00, and
- General Fund reserves as a loan to Library Impact Fees \$1,265,597.00

The current balance in the Library Impact fees is insufficient to cover the cost of the expansion match. Therefore a commitment from the General Fund reserves is required. The Library Impact Fees will reimburse the General fund reserve of 1,265,597.00 and will serve as a loan to be paid back every

quarter until the total amount is refunded to the County's General Fund reserves. Attached find the Board Resolution and Grant Award Letter.
