BACKGROUND/SUMMARY:

In September 2020, Governor Newsom signed into law Senate Bill 823 (SB 823) and Assembly Bill 1868, which will phase out the Division of Juvenile Justice (DJJ). SB 823 provides resources to counties for the delivery of services for youth previously sent to DJJ.

San Benito County Probation Department is entering into this agreement as a part of the commitment listed in the Juvenile Justice Realignment Plan submitted to the State. According to the SB 823 Juvenile Justice Realignment Plan, the San Benito County Probation Department has committed to contract with other counties through cooperative agreement to access services through host counties that can provide a higher level of services, when needed.
