Approve a capital budget adjustment to purchase a 2024 utility truck for an amount not to exceed \$80,000.00 for the Facilities/Grounds Maintenance department by re-allocating \$60,000.00 in approved capital equipment budget for a boom lift and a forklift to the 2024 utility truck and, transferring \$20,000.00 from the approved operating budget for the vehicle lease account to the fixed asset equipment other than computer account. (4/5 vote required)

BACKGROUND/SUMMARY:

The Facilities/Grounds Maintenance department needs another utility truck capable of carrying tools and other equipment necessary to respond to maintenance trouble tickets and emergency repair calls for County facilities. Response time to emergency or major repair calls takes longer due to four staff having to share two utility trucks and one regular pickup which is old and has more than 200,000 miles on it. Acquiring this additional utility truck would increase the department's efficiency in responding to trouble calls.

Operating budget of \$20,000 was approved in the department's vehicle lease budget which was earmarked for an additional truck lease over five years. However, management has determined that purchasing one from a local dealer for an amount not to exceed \$80,000.00 is more economical over the life of the asset. The balance of \$60,000.00 for the purchase would be funded by re-allocating the currently approved fixed asset capital equipment budget of \$60,000.00 for a boom lift and fork lift toward

the new truck purchase.
