BACKGROUND/SUMMARY:

In November 2023, staff applied for \$56,000 in grant funding through the Mattress Recycling Council (MRC) to help fund various outreach efforts that are aimed at educating community members about the penalties of illegal dumping and about the county-wide free disposal and recycling methods available. These outreach efforts will consist of quarterly postcard mailers regarding various bulky item recycling and disposal events offered to residents, illegal dumping signage to be located at various hot spots within the County, educational workshops for multi-family dwellings, and other tabling events throughout the year. Through these efforts, the goal is to observe an increase in various bulky item recycling and disposal program event participation and to increase educate the community about the issues of illegal dumping and the penalties for violations.

On December 27, 2023, staff was notified that our funding proposal was approved, however MRC must receive notice of County's acceptance.
