BACKGROUND/SUMMARY:

The California Department of Food and Agriculture (CDFA) has contracted with the County of San Benito to enforce the registration and inspection of any apiary located in the county. San Benito county is home to approximately 14 Apiaries and 11,500 Colony's as of January 1st, when apiary registration is required to be completed. The term of the contract is January 1, 2026, through June 30, 2027. The Apiary Protection Program Agreement of \$3,396.45 is a total of reimbursable funding allowed. The department will invoice CDFA monthly for expenditures incurred for the program.

The agreement is retroactive to January 1, 2026, due to the Apiary Protection Program Agreement FY 25/26 and FY 26/27 being received on December 22, 2025

This is a new contract with no previous history.

The Apiary Protection Program Agreement is a new contract and has no fiscal impact to our department.
