BACKGROUND/SUMMARY:

Trindel Insurance Fund and PRISM are joint powers authorities that provide risk management, insurance coverage, and related services to member counties. Active participation on their Boards of Directors allows the County to contribute to governance, policy direction, and oversight of services that directly impact County operations.

Appointing Ms. Barocio as the primary representative leverages her expertise in human resources, risk management, and employee benefits, which are closely aligned with the services provided by both Trindel and PRISM.

Appointing the County Executive Officer, Ms. Colio Warren, as the alternate ensures executive-level representation and continuity in the event the primary representative is unavailable.

Previously, the primary representative role was held by Henie Ring, Deputy County Administrative Officer, and no alternate representative was designated.

These appointments will support the County's ongoing engagement with both organizations and help ensure that the County's interests are effectively represented.

FISCAL IMPACT:

There is no direct fiscal impact associated with these appointment.

STAFF RECOMMENDATION:
