Adopt Resolution approving the Operation and Maintenance Contract #25-OMS-1859 between the State Department of Housing and Community Development (HCD) and the County of San Benito in an amount not to exceed \$1,951,996.20, for the utilization of sixty seven 2-3 bedroom units at the Southside Road Migrant Facility for seasonal housing between May and November; and authorize the HHSA Director or Designee to sign the two year contract for the period of July 1, 2025 through June 30, 2027, and any subsequent amendments to said contract that do not require a budget augmentation.

BACKGROUND/SUMMARY:

The Office of Migrant Services (OMS) contract is a 2-year contract covering fiscal years 2025-2027. Funds can be used for maintenance, broadband and the operation of the seasonal rental housing for migrant farm workers. The State has released the draft Agreement with instructions to counties to provide the State Office of Migrant Services (OMS) their approved resolution. OMS has provided the County with a sample contract for the Board's review. Once OMS receives the signed resolution from the Board of Supervisors, they will provide the Agency the contract for review and approval. The attached resolution and draft contract were provided to the Agency on April 18, 2025.

This funding is used to fund the operations of the San Benito County Migrant Center. The San Benito County Migrant Center's mission is to foster and promote safe and affordable housing opportunities for migrant seasonal farm worker families and other community services that will allow families to thrive. The

Migrant Center provides seasonal housing services for migrant farm worker families, utilizing sixty-seven (67), two- and three-bedroom units at the County's Southside Road Migrant facilities during the period of May through November. This program annually supports from 200 to 250 clients annually. The County has been providing these services to migrant farm workers for over thirty-two years.

The OMS funding contract #21-OMS-16171 was in the amount \$1,245,931 for the period 7/1/2021-6/30/2023.

The OMS funding contract #23-OMS-17840 was in the amount \$2,003,983 for the period 7/1/2024-6/30/2025.

The OMS funding contract #25-OMS-18590 will be in the amount \$1,951,996.20 for the period 7/1/2025-6/30/2027.
