BACKGROUND/SUMMARY:

The Board of Supervisors approved the purchase of an industrial water boiler for the Juvenile Hall Facility on November 23, 2021 in response to the Resource Management Agencies notification of an immediate loss of hot water at the facility. Hot water was provided to the Juvenile Hall occupants by way of a temporary shower mobile unit for a temporary solution. The materials order of the PVI brand water boiler unit from the manufacturer was impacted by significant material delays consistent with many construction and utility delays in 2021-2022. The water boiler was delivered by the manufacturer to the Juvenile Hall location in August 2022 and available for plumbing contractors to inspect and present a proposal for installation. Four (4) plumbers were contacted for a proposal, Messina Plumbing Company was the only vendor to submit a proposal.
