BACKGROUND/SUMMARY:

Behavioral Health clients may at times require inpatient, acute psychiatric hospital services to meet their acute care treatment needs. There is a statewide shortage of available psychiatric hospital beds so the Behavioral Health Department contracts with multiple hospitals to increase the options for psychiatric hospital bed availability. Behavioral Health is seeking permission from the Board of Supervisors to pay for several invoices for non-contracted inpatient hospitals and their doctors. Behavioral Health has several invoices for inpatient hospitals and Psychiatrists that provided acute psychiatric care for members of our community during fiscal year 22-23. Although San Benito County does not meet the requirements for a mandatory contract with these entities, per the Department of Health Care Services, the Behavioral Health Department has attempted to contract with many inpatient psychiatric hospitals for the current fiscal year. Behavioral Health has a process to reach out to hospitals throughout the fiscal vear to request contracts. The nature of hospital partnerships doesn't always allow for our department to receive signed contracts as this is not a mandate for the acute inpatient hospital in providing emergency based care for those in our community. Behavioral Health will continue to make every effort to have

contracts in place, but in order for Behavioral Health to maintain a cooperative partnership with these commonly used hospitals, we would like to ask permission from the Board of Supervisor to allow Behavioral Health to pay these invoices without a contract to become current on our billing.
