BACKGROUND/SUMMARY:

The Trindel Insurance Fund requires that each of the participating counties in the Joint Power Agreement appoint a voting member and the alternate to the Trindel Board of Directors. The County appointed members are to represent the County on the insurance fund board at the guarterly meetings. In the event that the primary designee is unable to attend, the alternate is authorized to vote in the capacity of the County appointee. The decisions the Trindel Board of Directors will encounter are financial in nature, including the evaluation of actuarial insurance valuations, funding policies, and loss reserve considerations.
