BACKGROUND/SUMMARY:

The San Benito County Mosquito Abatement Program was established in 2007 as a department within the San Benito County Agricultural Commissioner's Office. By Resolution NO. 2007-65 the San Benito County Board of Supervisors is authorized to levy assessments to provide Mosquito Abatement and Disease Control Services. The Engineer's Report for the County Mosquito Abatement program is prepared annually and determines the assessment rate needed to fund this program. For the upcoming fiscal year, the Engineer's Report is recommending the assessment remain at \$11.22 per single family equivalent. After discussion, the Board will need to pass a resolution of intent to levy the assessment for FY 2025/2026. The Board will also need to preliminarily accept the Engineer's Report and schedule a Public Hearing. The anticipated revenue and expenses have been budgeted in the Mosquito Abatement Program Proposed Budget for FY 2025/2026.
