#### **BACKGROUND/SUMMARY:**

Relias is a specialized software platform that currently provides a multitude of training courses tailored to the needs of Behavioral Health staff. For many years, access to Relias has been supplied through a contract Behavioral Health has had with IDEA Consulting, Inc and was shared among several counties with whom IDEA has a similar professional relationship. IDEA Consulting has opted to not renew their contract with San Benito County for Fiscal Year 2024-25

The need to become independently in control of the Departments' Training scheduling, tracking, planning and creation has become more apparent as the BH Department undergoes workforce growth. Since the Relias platform to which the BH Department have access is owned and operated by IDEA Consulting, some of the features for planning and creation of our own courses, as well as direct support, are not available.

The purchase of our own Relias platform will also give the Department the ability to maintain our array of

Policies and Procedures applicable to specific members of staff, with essential version control and tracking capabilities. BH Department will also be able to create new training materials in real-time to reflect DHCS requirements.

This agreement will be paid for through the non-general fund. The funding stream with by supplied by the CCMU grant.
