Adopt continuing Resolution confirming the Public Works Administrator's authority to enter into emergency repair and replacement contracts to remediate a local emergency caused by February 21, 2023 flooding and continuous flooding and storm events, pursuant to Public Contracts Code Section 22050, without adoption of plans and specifications or competitive bidding; finding that there is a need to continue emergency action; and finding emergency repair and replacement work exempt from CEQA under CEQA Guidelines Section 15269(d), as emergency projects within the rights of way of existing County and State highways damaged by flooding and storm events. BACKGROUND/SUMMARY:

On March 10, 2023, while the Board of Supervisors was not in session, the Director of Emergency Services, in response to major road and storm damage in the County of San Benito, proclaimed a local emergency effective immediately. That Proclamation was signed on March 10, 2023. Per Ordinance 833, the Board of Supervisors must ratify the Proclamation issued by the Director of Emergency Services within seven (7) days. This Proclamation applies to the entire County of San Benito. On March 14, 2023, by Resolution No. 2023-33, the Board of Supervisors ratified the Proclamation signed on March 10, 2023.

Due to the winter storms of February 21, 2023 and continuing, County Roads sustained substantial damages and are in need of immediate repairs, including such work as: pavement repairs; bridge repairs; shoulder and culverts clearing/replacement; slides and debris removal; new bridges/culverts; roadway section stabilization; etc., resulting in severe financial impacts on County residents and the County itself. As a result of heavy rainfall throughout the State of California, President Biden declared a major disaster on April 3, 2023 in several Counties, which was amended on April 14, 2023 to include additional counties, including San Benito County.

On October 24, 2023, the Public Works Administrator reported that the following emergency repairs have been completed:

- Aromitas Rd. - embankment stabilization is completed, but roadway repair is still in progress
- Cienega Rd. - slide repairs are completed
- Cole Rd. - sinkhole repair and roadway embankment stabilization are completed
- Limekiln Rd. - roadway reconstruction is completed
- Panoche Rd. - embankment stabilization is completed, but culvert replacement is still in progress
- San Juan Canyon Rd. - one embankment stabilization, one creek culvert, and roadway repair are completed, but culvert replacement is still in progress
- The Alameda - creek embankment repair is completed

This proposed resolution relates to the letting of emergency contracts under Public Contracts Code 22050 and must be reviewed by the Board of Supervisors at every regular meeting until the need for emergency action terminates.

The Public Works Administrator hereby reports that there is a need to continue the emergency actions.

Preliminary Summary of Road Damages

Public Works crews and contractors responded to numerous issues related to the 451-mile County Maintained Road System over the course of the storm, beginning on February 21, 2023, including:

- Downed Trees
- Debris and sediment on travel ways

- Flooding
- Slip outs/landslides/rockslides
- Surface damages/failures (pavement deterioration, potholes, cracking)
- Washouts
- Culvert failures

It is estimated that approximately \$4 million in repair costs are needed because of damages sustained during the event. Many County roads were affected; however, nine major (Arterial and Collector) roads were severely impacted. Most of those were in 'South County' (south of Hollister) and the Aromas area - where the largest rainfall amounts were experienced. Damage Assessments are continuing. The following roads (in alphabetical order) were the most severely affected:

- Aromitas Rd.
- Cienega Rd.
- Cole Rd.
- Cottonwood Rd.
- Limekiln Rd.
- Merrill Rd.
- Panoche Rd.
- San Juan Canyon Rd.
- The Alameda
- Anzar Rd.

Characterization of Repairs Needed

The needed repairs range from embankment stabilization to complete roadway reconstruction. Preliminary estimated costs by roads are as follows:

- Aromitas Rd. = \$350,000
- Cienega Rd. = \$750,000
- Cole Rd. = \$300,000
- Cottonwood Rd. = \$400,000
- Limekiln Rd. = \$900,000
- Merrill Rd. = \$200,000
- Panoche Rd. = \$140,000
- San Juan Canyon Rd. = \$750,000
- The Alameda = \$200,000
- Anzar Rd. = \$100,000

Additional debris cleanup and tree removal costs are approximately \$400,000.

In addition to County staff, the four contractors engaged in the work above are Granite Construction, Don Chapin Company, Llano Inc., and Graniterock.
