SUBJECT:

BEHAVIORAL HEALTH DEPARTMENT - D. EDGULL

Approve contract with Aurora Behavioral Health, Santa Rosa, LLC for a fee-for-service hospital contract for acute psychiatric inpatient hospital service for Medi-Cal beneficiaries required by the Department of Health Care Services for the term of July 1, 2025, through June 30, 2026, and authorize Chair to sign said agreement.

BACKGROUND/SUMMARY:

The State Department of Health Care Services (DHCS), through the 1915 B waiver process with the Federal Centers for Medicare and Medi-Caid Services, requires local county Mental Health Plans to provide an array of services for Medi-Cal beneficiaries. These include inpatient, residential, and intensive outpatient services to address a variety of psychiatric conditions.

This is an emergency service, and the county is contractually obligated through DHCS to provide these services regardless of price. Typically, we do not exceed \$500K for inpatient hospitalization. With CalAIM this price point may change, and the inpatient hospitals usually are in negotiations with the state months after the start of a new fiscal year. This contract does not have a not to exceed amount as it is state mandated for all Medi-Cal beneficiaries. At the December 13, 2022 Board of Supervisors meeting, the Board approved resolution 2022-150 giving the Behavioral Health Department the ability to pay this contract on a case-by-case emergency approval.

Behavioral Health clients may, at times, require inpatient, acute psychiatric hospital services to meet

their acute care treatment needs. Aurora Behavioral Health is an acute psychiatric hospital that provides services for adults, older adults and adolescents with acute psychiatric needs requiring hospitalization. There is a statewide shortage of available psychiatric hospital beds so the Behavioral Health Department contracts with multiple hospitals to increase the options for psychiatric hospital bed availability. In addition, hospitals can deny admission for an individual, so the Department needs options in case a facility will not accept a patient who needs to be hospitalized.

Clients receive evaluation and authorization to access psychiatric hospital services from Behavioral Health Department clinical staff. Our staff coordinates with the hospital staff (Hazel Hawkins Hospital Emergency Dept.) and physicians to provide the appropriate associated services.

This is a fee for service contract paid by Medi-Cal and other revenues such as 1991 and 2011 Realignment, and it is not paid for via the county general fund.

RFP AND BID HISTORY:
