BACKGROUND/SUMMARY:

Pursuant to SB 184 all alcohol and drug treatment programs must either offer Medicated Assistant Treatment (MAT) services directly to clients or establish an effective referral process with other MAT providers. In FY 24-25 Behavioral Health partnered with the provider Pacific Rehabilitation and Pain (PRP) to implement a MAT service program in San Benito County. The services provided by PRP fulfill the state mandate.

Behavioral Health estimates 315 clients have benefited from this program in the last year.

This is a single year term with no monetary component to the MOU.
