BACKGROUND/SUMMARY:

The State Department of Health Care Services (DHCS), through the 1915 B waiver process with the Federal Centers for Medicare and Medi-Caid Services, requires local county Mental Health Plans to provide an array of services for Medi-Cal beneficiaries. These include inpatient, residential, and intensive outpatient services to address a variety of conditions.

This is an emergency service, and the county is contractually obligated through DHCS to provide these services regardless of price. Typically, we do not exceed \$500K for inpatient hospitalization. With CalAIM this price point may change, and the inpatient hospitals usually are in negotiations with the state months after the start of a new fiscal year.

Behavioral Health clients may, at times, require inpatient, acute psychiatric hospital services to meet

their acute care treatment needs. Aurora Behavioral Health is an acute psychiatric hospital that provides services for adults, older adults and adolescents with acute psychiatric hospital needs. There is a statewide shortage of available psychiatric hospital beds so the Behavioral Health Department contracts with multiple hospitals to increase the options for psychiatric hospital bed availability.

Clients receive evaluation and authorization to access psychiatric hospital services from Behavioral Health Department clinical staff. Our staff coordinates with the hospital staff (Hazel Hawkins Hospital Emergency Dept.) and physicians to provide the appropriate associated services.

This is a fee for service contract paid for via the non-general fund.
