BACKGROUND/SUMMARY:

The project includes a 1.9-acre public neighborhood park in the southeastern portion of the project site. The proposed park could include shaded seating and picnic areas, open grass areas, a vista point with benches and/or picnic tables, and walking and/or bicycling paths. The park would not provide off-street parking, restrooms, or lit recreational facilities. In addition to the proposed park, 0.5 acre of passive open space would also be provided along the southern project boundary. Both the proposed park and passive open space would be dedicated to San Benito County for maintenance, funded through a CFD. Per San Benito County Code Section 23.15.008(D)(2), the applicant would pay in-lieu fees for the provision of additional off-site parkland in the County. In addition, the applicant shall pay in-lieu fees to meet requirement for 25.19.003(D) Planned Unit Development (PUD).
