**BACKGROUND/SUMMARY:**

San Benito County regularly issues contracts to complete construction and repair work throughout the county. These jobs can be small facility projects, or large public works emergencies. The State of California approved "Job Order Contract" program, establishes pre-negotiated contracts with established prices for anticipated work prior to the need. Resource Management Agency (RMA) completed a Request for Qualifications (RFQ) PL2021-003- Job Order Contract (JOC) Program, to provide consulting services related to the development, implementation, and support of the JOC Program and received one qualified response from the Gordian Group. This contract with the Gordian Group established the vendor as an administer for the JOC program for San Benito County. County has been working with the contractor (Gordian) to develop the scope of the program to provide the county with the most flexibility to reduce the response times for the customers.

2. Chappell Road House Remodel,
3. Cole Road Rehabilitation Project Closeout,
