**BACKGROUND/SUMMARY:**

The Union Road Rehabilitation project PWB-2403 is a roadway reconstruction between State Route 156 and extends to three miles beyond State Route 156. The scope of work includes a reconstruction of the existing pavement section, and striping and culvert installation. The funding for the repaving of this roadway segment was approved by the Board of Supervisors.

On September 9, 2025, the Board of Supervisors adopted the plans and specifications for the Union Road Rehabilitation project PWB-2403 and authorized issuance of the Invitation for Bids. The Chair signed the Invitation for Bids and the project was advertised for public bidding. On October 7, 2025, the County received nine Bids as follows:

The lowest responsive Bid was received from Granite Rock Company in the amount of \$3,151,457.00. Staff recommends that the Board of Supervisors award the bid proposal and authorize the Chair of the Board of Supervisors or their designee to sign the construction contract with Granite Rock Company. The contractor will commence work within 30 calendar days after the date of the Notice To Proceed and complete the work within 70 working days.
