Approve the Jovenes de Antano contract, to provide home-delivered and congregated meals for the elderly in San Benito County, from July 1, 2024 through June 30, 2025, for an amount of \$45,020.35 under the Community Programs Division budget for the Fiscal Year 2024-2025. Agreement retroactive to July 1, 2024, due to services rendered by Jovenes de Antano for Fiscal Year 2024-2025 and authorize the County Administrative Officer or designee to execute the contract.

BACKGROUND/SUMMARY:

The community programs division primarily allocates to private non-profit community-based organizations providing services to the most vulnerable individuals and families in San Benito County. Beginning in the Fiscal Year of 2017-2018 (FY17-18), the Board of Supervisors modified the program. The Board froze the allocation of \$120,000 and segregated it into two (2) sections, including a senior-based program allocation and other non-profits; 80k went to senior services, and 40k was part of a competitive grant before FY 21-22. During the recommended budget in FY 21-22, the Board of Supervisors eliminated the grant to other nonprofits, allocated a three percent (3%) increase to senior services, and directed further increases to align with the Consumer Price Index in the following years.

Jovene de Antano del Condado de San Benito, Inc., a non-profit organization incorporated in May of 1975, was established to encourage, develop, and administer programs to improve the general welfare of the elderly in San Benito County. Services are available to all elderly, including people with disabilities 18 years or older. Programs focus on the needs of the frail, low-income seniors that include the Latino community through the use of bilingual/bicultural staff, outreach into our rural areas, senior advocacy, and networking with local, regional, and national agencies that strive to meet common challenges.
