BACKGROUND/SUMMARY:

Within the past few weeks, there was a wildfire that spread throughout the hillsides adjacent to Anzar Road near Aromas and San Juan Bautista.

The location of this wildfire is adjacent to a current County sponsored roadway re-construction project, project No. PWB-2106. The Contractor for that project has expressed concerns that the burned trees could collapse into the roadwork area. During the evening of September 14th, a tree with burn scars did collapse into the roadway, however, there were no resulting injuries.

Following the collapse of the damaged tree onto the roadway, it was determined that removal of the 44

trees damaged by the fire, without adoption of plans and specifications or competitive bidding, is required as an emergency safety measure to avoid possible injuries to members of the public or damage to public property resulting from the further collapse of trees affected by that local fire, pursuant to Public Contracts Code Section 22050. The Interim RMA Director entered into a contract with The Davey Tree Expert Company to remove 44 trees affected by the local fire adjacent to Anzar Road for a total amount of \$66,020.00. A copy of the contract is attached to this Report. Staff is requesting the Board's ratification of the contract.
