#### **BACKGROUND/SUMMARY:**

The Chair will delegate the assignments of RCRC, GSFA, GSCA, CSAC, Behavioral Health Advisory Board, Public Defender Oversight Committee, COG and LAFCO for the year 2025 at this meeting as these boards and commissions have meetings the week of January 6th, 2025.

(CSCA, GSCA, and ESJPA are affiliated with RCRC and hold the same appointment as RCRC)

The Chair may also assign the remaining boards and commissions at this meeting or the chair may designate and appoint the remaining board commissions, standing committees, and ad hocs at a later

date.

The remaining 2024 Ad Hocs are attached. If there is a continuing need for a committee, they should be reappointed. If a committee is desired to be instituted as a long-term or permanent committee with an established jurisdiction over a certain subject, staff will evaluate their formation as a standing committee.

On October 22, 2024 the Board of Supervisors adopted by-laws for the Public Defender Oversight Committee which included 2 year terms for the Board Supervisors assigned to the committee to begin on January 1, 2025. The Chair will assign two Board Supervisors to the committee as well as an alternate for terms from January 6, 2025 through January 6, 2027.

The updated LAFCO Commissioner Handbook and Administrative Policies outlines member appointments are four year terms of office and any vacancy in the membership of the Commission shall be filled for the unexpired term by appointment by the body that originally appointed the member whose office has become vacant (Section 4.A). The County of San Benito has a vacancy due to Supervisor Gonzales' term ending on January 6, 2025. The newly appointed member will fill in the unexpired term that is set to end on February 28, 2027.
